



Annex A-1

- The Business Transaction Agreement (BTA) and its Supplemental Agreements (Agreements) between SFA Semicon Philippines Corporation (SSP) SFA Semicon Co. Ltd. (SSK) of South Korea originally took effect July 1, 2019. These two agreements were renewed to take effect July 1, 2020. Amendments were made on their term clause to provide for subsequent automatic for 1 year each on the BTA and 1 month each on the Agreements, at the same terms and conditions unless any of the parties gives a notice of its intention to change or terminate the agreement 30 days prior to termination.
- The BTA and the Agreements consist of manufacture-assembly and test packaging, processing and repair, etc. of semiconductor products by SSP for SFA and its Clients and the supply of raw materials, parts, finished products, and various production equipment by SSK to SSP or vice versa.
- The unit price shall be determined by agreement of both parties considering the contents, quantity of the Deliverables, title of intellectual property rights, labor cost, administrative expenses, inflation, other costs incidental to the business transaction and proper mark-up of both parties.
- SSP shall place an order with sufficient lead time so as not to interfere with the delivery by SSP when entrusting manufacturing, etc.
