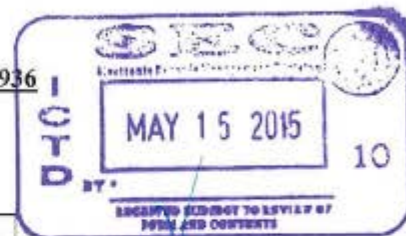
Corrections to the Approved Amendments to AOI & By-laws
