PSPC Receives Fifth Tranche of its Reimbursements under the Discounted Power Rate Program

Publicly listed Phoenix Semiconductor Philippines Corp. (PSPC) took payment of more than P22 million representing part of its receivables of the Company's discounted electricity incentive granted under Presidential Executive Order No. 856 and its Lease Agreement with Clark Development Corporation (CDC).

This amount is the fifth partial reimbursement of the Government through CDC of the power discounts for electricity utilized and fully paid by PSPC since the commencement of its commercial operations in 2011.

The discounted power rate program of the government supports power-intensive industries that pour in substantial investments in the country in order to make the Philippines more attractive to foreign direct investments.

The collection will increase the Company's cash and cash equivalents by approximately 450,000 US Dollars.
