PSPC Signs Various Construction Contracts for its Phase 2 Expansion Project

Phoenix Semiconductor Philippines Corp. (PSPC) has officially signed today (February 22, 2017) separate lump-sum construction contracts for various construction works in connection with the implementation of Company's Phase 2 manufacturing plant in Clark Freeport Zone (CFZ), Pampanga.

PSPC inked the contract for (1) electrical construction and installations and (2) temporary electric service works with DH Phils Electrical Corp. (DH Phil.). It also signed the contract for Heating, Ventilation and Air Conditioning (HVAC) and piping works with Jeon Seung Philippines Const. Corp. (JS Phil.).

Under the contract terms, DH Phil. and JS Phil shall undertake construction works and services, including supply of all equipment and materials, for their respective scope of work for the Phase 2 Main Process Building with an estimated production floor area of 18,000 sq. meters, the power utility building and an over bridge structure.

The contract price for the main electrical construction and installation work payable to DH Phil is KRW 655,433,000(\$ 573,445). The deadline for completion is no later than the end of August, 2017. On the other hand, the contract price for the temporary electric service work is KRW 140,000,000(\$ 122,487).

In regard to the HVAC and piping construction, the contract price payable to JS Phil. is KRW 2,224,700,000(\$ 1,946,412).

PSPC has set a strict construction timetable for all structural and related construction of the Phase 2 project to August 31 in accordance with the schedule to start installation of the required production facilities and equipment commencing September 1, 2017. The deadline for the ramp-up of manufacturing lines has been set on September 2017.

Mr. Byeongchun Lee, PSPC President, signed all the contracts disclosed in this statement, in line with the authority granted him that granted by the Board of Directors in 2016.

Pursuant to the requirements of the Securities Regulation Code, the issuer has duly caused this report to be signed this February 22, 2017 on its behalf by the undersigned hereunto duly authorized.
