"The sterling financial results we have achieved showcases the strides gained despite uncertainties in international economy and downtrend in the global semiconductor market," Mr. Joon Sang Kang, SSP Chairman and President, said.

He attributed SSP's financial results to the adoption of a global marketing strategy that consolidated the sales and marketing effort under the Company's Parent Corporation located at South Korea, SFA Semicon Ltd., (SSK) with SSP as the anchor semiconductor production hub in the region. This unified sales and marketing approach, he added, has enabled the Company to focus its capability, resources and efforts in manufacturing and customer quality assurance and control.
