SFA Semicon Announces Appointment of New Chairman and President

Publicly listed SFA Semicon Philippines Corporation (Trading Symbol: SSP), a global outsourced semiconductor assembly and test company, announced that Mr. Joon Sang Kang has been elected the new Chairman of the Board and President and Chief Executive Officer during the Board of Directors Meeting held today (December 26, 2018).

Mr. Kang's election becomes effective on January 1, 2019. He is to replace Mr. Byunggil Go, who has been reassigned to SSP's parent company SFA Semicon Co. Ltd. of South Korea (SSK) as Manufacturing Director.

"I am pleased to accept the position as Chairman of the Board and Chief Executive Officer of SSP," Mr. Kang said upon his election during the board meeting, "and commit to making the

Company perform better for the benefit of all stockholders.” He added that his familiarity and long experience with the Company’s operations and production management since its construction and start-up in 2010 will enable him to push its semiconductor assembly business to stronger recovery.

An industrial engineering graduate, Mr. Kang has been with the Company as Production Team Head for six years since 2011 when SSP was then named Phoenix Semiconductor Philippines (PSPC). He was part of the original engineering team that designed and implemented the Phase 1 semiconductor assembly and packaging system under the Samsung Electronics (Korea) production agreement which was forged under then parent STS Semiconductor and Telecommunications Co. Ltd. in 2010, now SSK.

Mr. Kang was temporarily assigned in SSK latter part of 2016 but he later took over his previous post as Production Team Lead in February 2018. He was then elected Director during the Company’s Board of Directors meeting held on February 13, 2018. Prior to joining then PSPC, he served as production manager of Samsung Electronics (Korea) for 14 years.

In the same meeting of the Board of Directors on, December 26, 2018. Mr. Joon Sang Kang was also elected by the Board to be the chairman of the Board Nominations Committee. Mr. Minhun Seo, who is concurrently the Utility Team Head of SSP, was elected Director in place of Mr. Go.
