2. Adjustment of Per Diem of Directors Attending via Teleconference

In response to the concern raised by one of the independent directors to the two-tiered scheme of per diems, whereby a director attending meetings via teleconference receives only 50% of the amount received by the director attending in person, the Remuneration Committee recommended the increase in the per diem allowance of directors and Board Committee members attending meetings by telephone conference to the same amount received by the director attending in person, i.e. \$1,000.00 for Board of Directors meetings and \$500.00 for Board Committee meetings or the peso equivalents on the day of the meeting, net of applicable withholding tax. The Board of Directors unanimously approved the said recommendation to take effect immediately.
