The Board of Directors of the Company, at its regular meeting held today, approved the following:

1. Unaudited Interim Financial Statements of the Corporation as of September 30, 2016

The Board of Directors of the Corporation approved the Corporation's Interim Financial Statements as of September 30, 2016, substantially in the form presented to the Board and recommended by the Audit Committee. Together with this approval comes the authorization to release and issue of the said Unaudited Financial Statements.

2. Filing of the Corporations SEC Form 17-Q not later than November 14, 2016

The Board of Directors approved the Corporation's SEC Form 17-Q, substantially in the form presented to the Board and recommended by the Audit Committee, as well as its release and issuance necessary for subsequent filing with the Securities and Exchange Commission and the Philippine Stock Exchange.

For this, each of the Chairman and President of the Corporations, Mr. Bycongchun Lee, and the Treasurer of the Corporation, Ms. Caroline S. Sicat, were authorized on behalf of the Corporation to sign, execute, deliver and receive any and all papers and documents, and otherwise do any and all acts necessary or appropriate, for the approval, release, issuance and filing of the said SEC Form 17-Q.

#### 3. Change in Currency of IPO Proceeds from Philippine Peso to US Dollar

The Board of Directors approved the conversion of the remaining balance of the Corporation's Initial Public Offering proceeds amounting to approximately PHP 423,535,777.00 from Philippine Peso to US Dollars. This conversion is to minimize the risk of peso devaluation and in anticipation of payments to be incurred for the construction of the S Project that are perceived to be made using the said currency.

## 4. Progress Update on S Project

The Corporation has already started the application with Clark Development Corporation (CDC) for the necessary permits for the construction of the S Project. The awarding and execution of the construction contract are in its final stages. Construction is expected to commence before the end of the year.

Pursuant to the requirements of the Securities Regulation Code, the issuer has duly caused this report to be signed this November 8, 2016 on its behalf by the undersigned hereunto duly authorized.
