"Total Amount Appropriated for the Buy-Back Program" is the sum of the original funding for the share buyback program of ₱130Million (approved by the Board of Directors on June 29, 2022) and the additional funding for the share buyback program of ₱73Million (approved by the Board on August 7, 2023)

The total amount of shares repurchased includes incidental costs such as broker's commission, VAT, and other PSE-mandated

As a result of the share buyback made on October 31, 2023, the remaining amount (from the total amount appropriated for the share buyback program of SSP), as of this date, is ₱41,794,208.84.
